- Affiliate - \$275** Individuals employed full-time by an airport or aviation authority.

Companies

- Corporate - \$850** Company with a business interest in airports and aviation. All staff are granted benefits under a company's membership.
- Associate - \$325** Individual with an interest in airports and aviation.

Students

- Academic - \$40** Full-time undergraduate student pursuing airport management or related field of study at an accredited university, and who is not employed full time in the field of aviation.*
- Academic Graduate - \$150** Full-time graduate student pursuing airport management or related field of study at an accredited university, or full-time undergraduate who wishes to enroll in the Certified Member (C.M.) Program, and who is not employed full time in the field of aviation.*

Other

- Participating - \$325** Individuals employed by or affiliated with a governmental agency or board having an interest in or charged with responsibilities with respect to airport management or administration of a public airport; or who is affiliated with a non-profit organization or educational institution with a direct interest in airport management.
- Military - \$150** Individuals who are serving on active duty in the military, actively employed with the U.S. Department of Defense, veterans, or retired military personnel as defined by the Veterans Benefits Administration Manual and are not employed full time at a public airport or in the field of civil aviation.**
- Young Professional - \$150** Introductory rate for first-time members 35 and under for the first year of membership. Automatically added to the AAEE Young Professional's Committee.
